

Stud Service Agreement for

It is understood and agreed that:

1. No bitch who has a disqualifying characteristic (per the GRCA standard) will be serviced,
2. Prior to breeding, the Stud Owner will be provided with copies of the bitch's:
 - (a) 3 generation (minimum) pedigree
 - (b) OFA certificate for hips (and elbows, if available)
 - (c) eye report conducted by a member of the ACVO within the last 12 months prior to the date of breeding, and/ or copy of current CERF Certificate.
 - (d) heart report performed by a member of the ,ACVIM (or an Internist working under the direct supervision of an ACVIM member) /or copy of OFA cardiac certificate
 - (e) a photograph or video
3. A negative current (within 30 days of the breeding) brucellosis report must accompany the bitch at the time of breeding. No service will be performed without the brucellosis report. It is strongly recommended the bitch also have a vaginal culture performed prior to breeding, especially if she has a history of reproductive difficulties. If culture results are not supplied, the stud owner reserves the right to accomplish the breeding via A.I. procedures.
4. The stud fee shall be \$1,200.00:
 - (a) Non-Refundable Deposit (NRD): \$400 of the stud fee shall be nonrefundable and shall be due when the bitch arrives for breeding, or prior to semen collection & shipping.
 - (b) The AKC Application for Litter Registration will not be signed until the stud fee is paid in full
 - (c) If less than three puppies are named on the AKC Application for Litter Registration, the fee for the stud service will be an additional \$200 to the NRD deposit of \$400:

Example:

No. of pups on appl.	Total puppy fee	Total stud fee (Inc. NRD)
1 or 2	\$200	(\$200 + \$400) = \$600
3+	\$800	(\$800 +\$400) = \$1,200

- (d) If no puppies result from this mating, no payment will be due the Stud Owner (other than the NRD of \$400 described in (a) above and the bitch's expenses described in #6 & #7 below), and there will be no further obligation on the part of either the bitch's or the stud's owners.
5. A safe, comfortable and pleasant environment will be provided for the bitch while she is at our home. Specific care instructions will be carefully followed to the best of our ability. Every effort will be made to

provide for her safe care & confinement; however, the stud dog owner (or the dog's agent) shall not be held legally or financially responsible in any way for her injury or loss, or for damage or injury caused by the bitch while in our care.

Should the bitch become ill, the bitch owner authorizes any and all, emergency care necessary for her well being. Every attempt will be made to contact the bitch's owner prior to undertaking treatment with the understanding that should an emergency arise, this may not be possible. In that case, bitch's owner will be contacted as soon as possible after treatment.

6. Additional Expenses:

Medical expenses, including those pertaining to artificial insemination and/or the collection and shipment of semen, shall be the sole responsibility of the bitch's owner.

Airport transportation Fees (to Sacramento (SMF) or San Francisco (SFO) airports):

For pickup and delivery of the bitch: No fee (other than the \$400 NFD described in #4 above)

Counter-to-counter shipped semen: \$100 for the cost of the semen kit (other than the \$400 NFD described in #4 above) will be due for the first shipment. If additional shipments of semen are requested by the bitch's owner, a \$50 per shipment fee will be charged in addition to the cost of each semen kit. There is no additional fee for overnight shipping (Fed-Ex, etc.).

7. Boarding will be provided free of charge for 10 days starting with the day the bitch arrives for breeding. Thereafter, a charge of \$20.00 per day will be charged. No bitch will be boarded more than 14 days. Any required medications must be provided at the time the bitch is shipped, along with instructions. We feed Purina Pro Plan foods. If your bitch requires a special diet (or medications), please plan on sending it with her at the time of shipping.
8. The stud dog owner requires that the puppies resulting from this breeding not be sold to wholesale dealers, and will not be sold overseas.
9. The stud dog owner requires that puppies resulting from this breeding which are placed in non-competition homes be sold on spay/neuter contracts and limited registration.
10. The bitch owner(s) agrees to provide the stud dog owner with a list of the names, addresses, phone numbers, and e-mail address of all owners of puppies resulting from this breeding. The name, address, and phone number of the stud dog owner shall also be provided to all puppy owners.
11. The bitch owner agrees to provide general health & genetic clearance information for the litter (if known) to the stud dog owner. All such information is strictly for the stud dog owner's personal use and shall remain confidential.
12. The stud dog owner reserves the right to refuse service to this bitch for any reason. In this instance, no stud fee or NFD will be due, however all other expenses (including shipping/medical/board/etc.) remain the responsibility of the bitch owner.

After reading the above terms and conditions, we find them mutually agreeable and acceptable.
